Members retiring from the Committee after completion of three full tenure at a stretch shall not be eligible for re-election , However, they shall be eligible for re-election after a break of one term.

As decided by the Council at its 691st Meeting held on 24-25 Sep 2016 at Haridwar, candidates desire to contest in the elections of the IEI shall deposit Rs. 3,000/- as non-refundable earnest money by demand draft drawn in favour of "The Institution of Engineers (india)" , payable at Kolkata.
