### Report of 44<sup>th</sup> Annual General Meeting of North Bengal Local Centre (IE)

The 44<sup>th</sup> ANNUAL GENERAL MEETING of North Bengal Local Centre (IE) was held on 25<sup>th</sup> April, 2021 (Sunday) at the NBLC(IE) new building, P.O.- Jalpaiguri Government Engineering College, Dist. Jalpaiguri-735102 at 11.00 A.M.

26 Corporate Members attended the A.G.M. through physical mode and 12 Corporate Members attend the A.G.M through Online mode.

The Chairman, Er. Gautam Das heartily welcomed the members present and inaugurated the 44<sup>th</sup> A.G.M. with a brief speech on the progress of the NBLC (IE) with the cooperation of all the members, attached to the Centre. He said that in view of the recent surge in the COVID-19 pandemic and the consequent restrictions by the Government the A.G.M has been conducted in hybrid mode (i.e. Online and/or Physical mode). Thereafter following self introduction of the members present, the Chairman called the meeting to order.

The Honorary Secretary, NBLC(IE) read out the pre-circulated notice and agenda of the 44<sup>th</sup> AGM and also read out the minutes of the 43<sup>rd</sup> AGM which was confirmed by the House. The Honorary Secretary then presented the Annual Report of the NBLC (IE) for the fiscal year,

2019-2020. It was followed by general discussion on the activities mentioned by the members present. The members in general expressed their pleasure at the activities of the Centre. The Honorary Secretary Er. Santanu Das presented the Audit Report of NBLC(IE) for the financial year 2019-20 and the house approved the same. The house decided to re-appoint M/s. R. Ray & Co as the Auditor of the NBLC (IE) for the year 2020-2021.

The Honorary Secretary informed that due to the emergency situation caused by Covid-19 pandemic, IEI-HQ notifies that the elections of the Chairman, Honorary Secretary and committee members of NBLC(IE) scheduled to be held in the year 2020 are postponed by one year i.e. to be held in the year 2021. The term of the Chairman, Honorary Secretary and committee members of the North Bengal Local Centre (IE) committee which is getting completed in 2020 also stand extended accordingly by one year i.e. upto 2021".

There being no other business to transact, the Chairman, Er. Gautam Das dissolved the AGM at 12.30 p.m.
